2. GUEST EDITORIAL L'ÉDITORIAL DE L'INVITÉ

Let's Hunt Zombies!

Doctrines are the bedrock of sound legal scholarship and provide the differentia specifica to political science or legal philosophy or essayistic writing. But being abstractions doctrines may detach from the thematic context and the problem for which they were developed. Sometimes a problem is later solved by other and more efficient means or loses its relevance by the passing of time, but the originally developed doctrine, now functionless, can still haunt the lines of legal argumentation, doctrinally "undead". Both pride and misery of doctrinal scholarship spring from the same source: the pride of system-building and the development of autonomous concepts, and misery over an entanglement with abstraction that has lost its functionality.

The doctrines of monism and dualism provide a fine example. They are among the proudest achievements of the foundational period of international scholarship as an autonomous legal discipline. They reveal the greatness and flaws of its classical paradigm. As often happens with doctrinal constructions, the context of their origin, the first thirty years of the last century, has largely been eclipsed by the time of today's doctrinal debates. Indeed, if one compares the contemporary situation with that of a hundred years ago, almost every relevant element has changed: the evolution of the nation state with the process of globalization, the unfolding of international law, general constitutional adjudication, and, above all, positive and differentiated constitutional provisions on the role of international law within the domestic system.

Any doctrine should help to explain the law, apply the law, develop the law. In every respect, monism and dualism are today unsatisfactory. The reasoning of monist or dualist texts appears rather hermetic and apodictic, and not linked with

the contemporary theoretical debate which should provide the broader horizon of doctrinal constructions. Monism and dualism only create confusion, particularly in classrooms, since those jurisdictions which are commonly styled as monist or dualist do not meet all the criteria the doctrines require them to fulfil. As normative guidelines, they are unsatisfactory as they do not assist in solving legal issues. Monism and dualism should cease to exist as doctrinal tools for discussing the relationship between international law and internal law. They are “zombies”, soulless remnants of another time, and should be buried as doctrinal arguments. If there should be any need of proof for this assertion, consider the debate on the ECJ’s Kadi decision. They might play one minor, but useful role: to make political statements on “friendliness” or “scepticism” about international law. But anyone partial to such rhetoric should be told that these concepts are inadequate for any in-depth argument.

Another fine example of a doctrine in need of a final resting place is that of state (not popular) sovereignty as the origin and nucleus of international law. The prohibition of the use of force, self-determination and non-discrimination are far more promising to fill its former role in most respects. Yet, more than any other doctrine, hunting the zombie of state sovereignty might provide a worthy script for the likes of Peter Jackson or Quentin Tarantino.

Such an exercise of clarification and purification is essential for doctrines to remain meaningful. Far too little is done in this respect, as many standard textbooks demonstrate. Given the importance of doctrinal approaches to international scholarship in Europe, such critical doctrinalism appears particularly well suited for the European Society of International Law, as a possible element of its progressive and distinctive identity.
