# Scoping the Field of EU External Relations Law at Sixty

### 17 July 2017, 13:30-19:00 h Council Room, Faculty of Law, Tiensestraat 41 Leuven

## 1. Concept

This seminar seeks to explore the most salient issues in the European Court of Justice's case law on EU external relations in the year that marks the 60<sup>th</sup> Anniversary of the Treaties of Rome. The past 10 months have seen a number of key judgments and opinions being handed down in this field. Developments of particular significance have taken place on two main strands. On the one hand, Opinions 2/15 and 3/15 (as well as pending Opinion 1/15) raise questions for reflection on the future of the EU's **common commercial policy** and on the nature of EU **external competences** in general. On the other hand, a series of judgments in the area of the **common foreign and security policy** seem to provide guidance as regards the Court's interpretation of its limited jurisdiction in this policy domain. *H v Council, Rosneft* and *Elitaliana*, but also earlier cases such as *Tanzania Agreement* and *Mauritius Agreement*, slowly build a significant body of case-law in this regard. This is linked to other judgments, such as the orders in which the General Court declined to rule on the EU-Turkey Statement.

In order to assess these developments, the seminar, which takes place on the basis of Chatham House Rules, is structured around two main sessions. Following short presentations of maximum 10 minutes on the main issues touched upon in the case law, academics as well as practitioners coming from the legal services of the institutions and from the European Courts will be invited to comment.
