The Law and Practice of EU Diplomacy in Regional and Global Organisations - Jean Monnet Doctoral Workshop

Jean Monnet Doctoral Workshop organised by EUDIPLO and the IG "the EU as a Global Actor" (Geneva) and the University of Geneva (online event). The doctoral workshop included panels on the EU's participation in international organisations; EU and migration; human rights and gender; the environment and climate change; and public health. The workshop included discussants and chairs from the ESIL IG EUGLOBAL, invited academics and experts from international organizations.

28/01/2022 AI in the EU and Access to Justice

Expert Panel Discussion organised jointly with the Department of Legal Studies, Central European University and the Europa Institute of Leiden University

The fundamental question this panel discussed is how the use of AI by the EU administration affects individuals' access to justice. Do the current rules, models, and procedures set up in the EU legal system to ensure individuals

can meaningfully object to and challenge public power still work in the face of automation?

After an introduction by Mathias Möschel (Central European University) and Melanie Fink (Leiden University/Central European University – IG EUGLOBAL co-convenor), the presentations focused on two central themes. The first concerned rights and fundamental principles particularly affected by the use of AI. The second theme related to accountability for and effective remedies against administrative decisions that rely on AI technology.

The speakers pursued a two-fold aim. First, taking an outside view on the EU's exceptionalism with its both inclusionary and exclusionary tendencies, the Agora explored how international law responds to this

ambiguity and accommodates the EU as a global normative actor in its framework. Second, and more broadly, this panel also aimed to bring together two academic disciplines that have increasingly drifted apart, namely EU law and international law.
