# ESIL Interest Group on Peace and Security – Annual Report 2021

#### 1. New committee members

Two new conveners were elected to the committee: Dr Patryk Labuda, Assistant Professor at the University of Amsterdam, and Dr Erin Pobjie, Lecturer in Law at Essex Law School.

### 2. Catania Research Forum - April 2021

The effect of the COVID-19 pandemic meant that the ESIL Research Forum at Catania was postponed until April 2021, when it ran online. Our side event focused on the effect of solidarity on both statehood and the use of force, from the perspective of peace and security. Our first panel, on solidarity, was chaired by one of our new conveners, Dr Patryk Labuda, composed of three speakers: Eva Nanopoulos (Queen Mary), who spoke on the topic of 'Solidarity in the law of peace and security: A neoliberal utopia?,' Niko Pavlopoulos (UCL), who spoke on the topic of 'Solidarity with the state, competing governments, and the quest for peace and security' and Rachele Marconi (University of Macerata), who presented 'Solidarity and Justice for War Crimes Against Women: Examples and Perspectives.' Our second panel, chaired by our second new convener, Dr Erin Pobjie, had two speakers: Kenneth Chan (Walther Schucking Institute of International Law), who presented 'Threats of force and the fickle politics of extra-legal solidarity' and Agata Kleczkowska (Institute of Law Studies, Polish Academy of Sciences), who presented 'From solidarity to hegemony in the law of the use of force.' The second panel, which focused on the use of force, was supplemented by discussion of the papers by Professor Emanuele Cimiotta.

The side event was received well by the attendees and a fruitful discussion on the nature of solidarity took place, prior to the Research Forum itself.

### 3. Annual Conference – Stockholm, September 2021

We also ran a pre-conference workshop prior to the ESIL Annual Conference 2021, held in a hybrid format in Stockholm. Our event was completely online and was well attended by the membership. Our speakers were:
