Past activities (2022/2023)

 Pre-conference workshop ESIL2023, 'The De-Legalization of International Law', Aixen-Provence, 30 August 2023

At our third pre-conference workshop at the Annual Conference, the IG discussed different dimensions of de-legalization trends across different branches of international law. The workshop had a conference-style format, with 16 paper presentations. • The Aesthetics of International Law', Central European University, Vienna, 12-13 May 2023

On 12-13 May 2023, we held a conference on 'The Aesthetics of International Law' at Central European University in Vienna. This interdisciplinary event brought together some 40 scholars from all continents, exploring various ways to visualize international law across contexts and media and reflecting on how such visualizations affect our perceptions and understanding of the system. The conference was webcasted and the full footage is available here. We are currently exploring avenues for publication of the most promising conference papers.

Methods course


We held an online social science methods workshop series in Fall 2022. Each session was about 3-4 hours and gathered around 20-30 students. The methods series were coorganized by Ezgi Yildiz, Umut Yüksel, and Chanya Punyakumpol. The sessions were taught by the following instructors:

Future activities

Speaker series

We are developing a new initiative with the ASIL IG on International Law and Social Sciences (ILASS). We will run a joint speaker series featuring interdisciplinary scholars whose research is at the intersection of International Law and Social Sciences. We plan to hold monthly sessions starting from October 2023 and schedule 3-4 sessions per semester. The members of the coordinating committee of both IGs will take turns in hosting/moderating the sessions. The series will be held online, and each session will last about an hour. We created a long list of speakers that reflects the diversity of theoretical and methodological approaches and includes a mix of junior and senior scholars. We also paid attention to gender balance and geographical representation. Of that long list, each semester we will select speakers. Our purpose is to create a platform for interdisciplinary scholars to share their research and for students to gain insights into how to carry out research at the intersection of international law and social sciences. The list of confirmed speakers for the Fall 2023, include Sergio Puig, Anthea Robers, Taylor Johnson, Erik Voeten, and Shiri Krebs.
