The Coordinating Committee has explored the idea of an online workshop concerning the recent Noble Prize Award in Economics and sent out inquiries to potential speakers, but it has been difficult to find enthusiastic participants for an online-only workshop. We are furthermore hoping to set up a more general collaboration with the American Society of Legal History in the future. Lastly, the Coordinating Committee is working on a proposal related to an interest group book or article prize in the field of the history of international law, following initial consultations with the ESIL IG Coordinators.
