The current emphasis on sustainable development at the national, regional, and international level calls for a deeper understanding of the role of regulatory instruments towards sustainable development. While regulatory instruments could encourage, mandate, and enforce sustainable practices and initiatives, they could also discourage or prohibit such endeavours. To deepen our understanding of the role of regulatory instruments towards sustainable development, this conference focuses on how behavioural insights could inform regulatory instruments to ensure that effective sustainable practices and initiatives are encouraged instead of discouraged. Such research is timely, as the unsustainable use of resources is likely to trigger effects unprecedented around the world. However, the application of rational choice theory, which has been the dominant theory of human behaviour in law and policy for several decades, have been shown to discourage or prohibit sustainability practices and initiatives needed to promote sustainable development.

This conference brings together researchers from different disciplines including law, psychology, political science, and economics to explore the potential of using behavioural insights in law- and policy-making to promote sustainable development, as well as how to overcome the challenges associated with it. This conference aims to (1) refine our understanding of human decision-making and its relevance to regulation and governance towards sustainable development, to (2) find ways to overcome the challenges of integrating behavioural insights into regulatory design, and to (3) sketch the future research agenda to integrate behavioural insights into law- and policy-making. As such, this conference builds upon and informs current efforts by governments, the private sector, and, most recently the UN, to apply behavioural insights to regulatory interventions.

Support for the conference and publications that are to follow is provided by the Deutsche Forschungsgemeinschaft (DFG) for International Scientific Events as part of Dr Eva van der Zee's project on behavioural governance and sustainable development. This workshop will be the second event of the ESIL IG Social Sciences and International Law. Due to the current situation, the conference will be held online.
