"Is International Bio Law Fair? Reflections on recent developments and future paths on their principles and their application"

CALL FOR PAPERS

The ESIL Interest Group on Bio Law will hold a pre-conference Workshop on "Is International Bio Law Fair? Reflections on recent developments and future paths on their principles and their application".

ESIL-SEDI members working on Bio Law and related areas are welcome to take part in this initiative. We encourage you to participate in this International Workshop.

The general topic of the conference allows us to reflect on the evolution of the concept of 'fairness' in the field of International Bio Law in recent decades, including by reference intergenerational equity. International Law in general, and Bio Law, in particular, have witnessed profound changes in matters that affect human health and life. In addition, it ought to face new challenges in the near future.

According to Salcedo Hernández, "Bio Law constitutes a new way of dealing with the search for a solution to conflicts posed by the modern era" ¹. From that point of view, Bio Law has to deal with issues related to human rights and the progress of science and technology, including Artificial Intelligence and "neurorights". Furthermore, in recent years the debate about the possibility but also the opportunity of manipulating the human genome for different purposes has emerged. In addition, old problems such as the access of vulnerable groups to the application of general standards or the regulation of euthanasia have to be considered in a fairer Bio Law. All this can be thought of against the backdrop of the necessity of giving specific responses by International Law.

Other topics arise in the recent years, such us Artificial Intelligence Biolaw, which opens the possibility to talk on Biolaw beyond biology; Animal Rights and the possibility of giving these biological non-human individuals/species rights and obligations, that is legal capacity in our legal systems; or even the recognition of bio-systems (oceans, forests, rivers, or even the Nature as a whole) as subjects of International Law

For these reasons, this workshop will allow us to stop and look back, to reflect on fair or unfair progress, as well as to analyze the near future of these matters that are of great importance to humanity as a whole.

- Access of minorities or vulnerable groups, including indigenous peoples to Bio Law
- Far/unfair responses of International Law, including Human Rights, to specific issues of Bio Law.
- Fairness in response to pandemics: lessons from COVID-19
- Artificial Intelligence and Bio Law beyond biology
- Animal Rights and the fairness of their recognition
- New Bio-Subjects in International Law
