# Fairness in International Business and Human Rights Law

Fairness may appear, at a very first sight, an implicit and almost established concept underpinning contemporary legal developments and scholarly discussions in the field of business and human rights. But, in practice, what does fairness mean in this context? How does it apply to specific situations? How can ideas of fairness be translated into international legal norms and standards? Have the meanings and perceptions of fairness evolved over time, and if so how has this impacted on the law? And even more problematically, is fairness a viable and appropriate concept through which examining, and perhaps assess, the international law in the field of business and human rights?

In line with the theme of the 18<sup>th</sup> ESIL Conference, the discussions at the annual workshop of the Interest Group on Business and Human Rights will revolve around questions of fairness in relation to international law on business and human rights.

Within this broad theme, we invite contributions that explore the different aspects and/or dimensions of fairness in the field of business and human rights, or that present different approaches or perspectives to fairness in this context. We very much welcome papers that seek to provide a critical reflection on this topic.

Possible aspects to be addressed in the workshop and areas of discussion may include, but are not limited to:

- What are the procedural and substantive dimensions of fairness in the law of business and human rights?
- Is the international law on business and human rights fair? Should it be? Can it be?

- Are there criteria to assess the level of fairness of norms and standards in the field of business and human rights?
- Do we need different approaches to fairness in dealing with businesses responsibilities in times of armed conflict?
- How and to what extent does the concept of fairness guide the international protection of the environment and shared resources?
- How and to what extent does the concept of fairness influence the protection of the rights of future generations?
- Is fairness a guiding factor to assess the business and human rights implications in international investment law?
- How may the concept of fairness be used to evaluate the human rights impacts of technological developments?
- How is the concept of fairness included in the development of due diligence obligations?

We also aim to ensure balance between more senior scholars and early career researchers.
