On the occasion of the 18th ESIL Annual Conference on "Is international law fair?", the Interest Group on International Business and Human Rights invites its members and other interested academic and experts to join a discussion about the question of fairness in international business and human rights law.

Background

Fairness may appear, at a very first sight, an implicit and almost established concept underlining contemporary legal developments and scholarly discussions in the field of business and human rights. But what, in practice, does fairness mean in this context? How does it apply? How can ideas of fairness be translated into international legal norms and standards? Have the meanings and perceptions of fairness evolved over time, and if so how has this impacted on the law? And even more problematically, is fairness a viable and appropriate concept through which examining, and perhaps assess, the international law in the field of business and human rights?

In line with the theme of the 18th ESIL Conference, the discussions at the annual workshop of the Interest Group on Business and Human Rights will revolve around questions of fairness in relation to international law on business and human rights.
