Giulio Bartolini is Full Professor of International Law at the Department of Law, University of "Roma Tre", where he is also Director of the Roma Tre International Humanitarian Law Legal Clinic, and lecturer at the Geneva Academy of IHL and HRs.

Prof. Bartolini is Editor-in-Chief of the Yearbook of International Disaster Law (Brill), Editor of the e-journal 'Questions of International Law' and member of the editorial committee of the Italian Yearbook of International Law.

Prof. Bartolini has been appointed co-director of the 2024 session of the Centre for Studies and Research of the Hague Academy of International Law (Topic 'International institutions in the face of international crises").
