In our workshop, we explore the role of international, regional and domestic courts, tribunals, and other adjudicatory bodies in reconstructing international environmental law. At a time when environmental challenges demand urgent and coordinated legal responses, adjudication on the basis of international environmental law has emerged as a crucial arena for contestation, innovation, and norm development.

We welcome submissions that critically examine how adjudicatory bodies contribute to the reconstruction of international environmental law. Topics of interest include, but are not limited to:

1. The impact of recently concluded and/or still pending climate change and environmental cases before international, regional and domestic courts and tribunals.
2. The actual and potential role of advisory opinions and pending advisory proceedings in shaping environmental obligations.
3. The interaction in adjudication between environmental law and other areas of international law, in particular human rights law.
4. Procedural innovations and challenges in environmental litigation.
5. The role of non-state actors, including Indigenous communities, in international environmental adjudication.
6. Judicial rationale and innovative reasoning and other methods applied by courts.
7. Reconstructing the sources of international environmental law.
8. The role of international environmental law in the interpretation of norms of international law from other fields.

We particularly encourage contributions that adopt an interdisciplinary approach, engage with novel theoretical perspectives, or propose forward-looking strategies for strengthening the role of adjudication in reconstructing international environmental law.

### **Submission Guidelines**

Submissions are welcome from scholars, practitioners, and activists across disciplines and

career stages. Presentations should present original research or novel theoretical insights that align with the conference theme, i.e., reconstructing international law.

Abstracts of no more than 500 words, along with a short (200 words) biography, should be submitted by 20 April 2025. Participants will be notified about the outcome of the selection process by 30 April 2025.
