Workshop Format

Departing from conventional academic formats, this workshop is designed to generate conversations that engage not only individual papers but broader thematic and methodological questions. The workshop will include brief mini-presentations from each panelist, followed by a conversation elicited by thematic questions that connect the papers with each other and broader themes under international law. A central thread running through the workshop is a shared concern with the genocide in Gaza and the broader occupation of Palestine. The event asks how the genocide and occupation press on every aspect of international legal thought and practice, and what they reveal about (the failures and promises) of international law, including the potential and value of critical approaches in the field today. The workshop will move towards and conclude with a roundtable on how the genocide in and the occupation of Palestine reveal international law's structural limitations in addressing colonialism, racialized violence, and gross human rights violations. It will reflect on what we, as international lawyers and members of professional institutions such as ESIL and universities, could and ought to do in response to genocide in Gaza, including how we might critically reconsider our scholarship and professional practice.
