On What Basis Should International Law be Reconstructed?

DESCRIPTION AND PURPOSE

Convened by the ESIL Interest Group on International Legal Theory and Philosophy, this workshop explores what the reconstruction of international law could or should entail. In recent decades, critique has shaken the foundations of international law, exposing its complicity in power and politics. The self-image of a neutral, problem-solving system has given way to a more reflective and contested view. If reconstruction is still a worthwhile goal after critique, its meaning, goals, and actors must be thoroughly reconsidered and re-imagined through dialogue, debate and, if need be, contestation.

Accordingly, the workshop asks participants to take a fresh look at the future of international law by reflecting on the theoretical dimension of how (and to what extent) a more just, inclusive, and normatively grounded international legal order might surge learning from its assumptions and setbacks.
