09/2025 **Webinar: The ICJ Advisory Opinion on Occupied Palestinian Territory and the European Union: Legal Reflections**

The ESIL Interest Group 'The EU as a Global Actor' (IG EUGLOBAL), in partnership with the University of Groningen and The City Law School City St George's, University of London, organised a hybrid workshop on 29 September 2025 on "The ICJ Advisory Opinion on Occupied Palestinian Territory and the European Union: Legal Reflections".

The webinar examined the legal implications of the International Court of Justice's 2024 Advisory Opinion for the European Union. It focused on the 'Expert Legal Opinion on the Implications for the European Union of the July 2024 International Court of Justice Advisory Opinion regarding the Policies and Practices of Israel in the Occupied Palestinian Territory' by Professors Gleider Hernández and Ramses A. Wessel. The discussion explored the EU's obligations under international law in relation to occupied territories and the potential consequences for EU policy and action.
